Camporee Rules & Expectations

Rule 1 – God First

• Camporee is full of fun—lake time, shooting sports, and exciting activities—but the most important part is encountering God. Powerful messages, altar time, and seeking the Holy Spirit are at the heart of this camp. Attendance at all services is required. Let's keep God first in everything we do.

Rule 2 - Safety is Paramount

• Boys must never be left unsupervised or placed under the care of other minors. They must be accompanied by an adult to and from all activities at all times.

Rule 3 – Live By the Code

• A Royal Ranger lives by the code. Be courteous, obedient, and respectful to both Camporee and Camp Whitsett staff. Represent Christ well through your actions and words.

Rule 4 – Obey Campground Rules

- As guests of Camp Whitsett, we must go above and beyond to honor their rules. Violations may result in immediate dismissal without a refund.
- 1. No open fires allowed
- 2. Registration opens Thursday at 1:00 PM no early arrivals
- 3. Lights Out: 10:30 PM 5:00 AM
- 4. Park only in designated areas
- 5. No parking or driving into campgrounds (\$500 fine)
- 6. No driving through rivers or creeks
- 7. Dishwashing only in designated areas (not restrooms, spigots, or streams)
- 8. Place all trash in containers or bags at the designated roadside pickup
- 9. No bikes, skateboards, or rollerblades
- 10. No personal firearms confiscated and not returned

Rule 5 – Leave No Trace

"A Royal Ranger always leaves the campground better than he found it."
 Keep campsites clean, restrooms and showers orderly, and do not cut trees or remove road-marking logs. Leave no trace behind. No fires are permitted under any circumstances.

Rule 6 - Your Schedule is your Guide

• Each outpost will receive a specific schedule for lake time, activities, and events. If it's not on your schedule, it's off-limits.

Rule 7 – No Forms, No Activities

 Boys will not be allowed to participate in any activities unless all required forms are fully completed and signed by a parent or legal guardian.

Rule 8 – It is just for fun!

• Tournaments are a fun tradition, but sportsmanship is key. No heckling, arguing with referees, or disrespectful behavior—on or off the court. One warning will be given; continued violations will result in forfeit.

Leaders: Boys must show proof of grade to verify age group eligibility for tournaments. No exceptions



- 1. Los Angeles to Bakersfield 1 hour 52 min (111 miles)
- 2. Bakersfield to Kernville 1 hour 4 min (52.4 miles)
- Kernville to Johnsondale 42 min (24.5 miles) Drive through Johnsondale on the Hwy 99
- 4. Johnsondale to Camp Whitsett 12 min (4.1 miles)
 - a. Continue on Hwy 99 for 0.6 miles
 - b. Turn right onto Forest 22S82 and drive for 2.5 miles
 - C. Turn slight right when you see the Camp Whitsett Sign and follow the road down the hill until you get to registration

From the Southern Central Valley & the Los Angeles Area

- Take Interstate 5 North to CA-99 North to Bakersfield.
- Then take CA-178 East 40 miles to Lake Isabella.
- Exit at CA-155 W and travel 11 miles up the edge of the lake to Kernville. (Stay right when CA-155 turns left; continue straight on Wofford Heights Blvd. and Burlando Rd.)
- Turn left on Mountain Road 99 Labeled "Sierra Highway" (a T-intersection) and go 26 miles to R-Ranch at Johnsondale.
- About a mile past Johnsondale, is forest service road 22s82 which takes off to your right; it is signed for Camp Whitsett and also for Peppermint Campsite and the Wilderness Trailhead.
- Camp Whitsett is on the right, after three miles and public campsites numbers 1,2, and 3 (and over 3 bridges)

From the Mojave Desert (Las Vegas, Nevada, & Inland Empire)


- From the intersection of US Highway 395 and CA-58 (Kramer's Junction/Four Corners), go North 50 miles on the 395.
- Take the signed offramp to CA-14/Inyokern West for five miles; turn left again onto CA-14 South.
- After three miles, turn right onto CA 178 West.
- Take the 178 for 32 miles and turn right onto Sierra Way; take this for 17 miles on the East edge of the lake into Kernville, and then another 20 miles to R-Ranch at Johnsondale.

- Camp Whitsett is on the right, after three miles and public campsites numbers 1,2, and 3

Outpost Patrol Flag Creation Guidelines

These important guidelines are here to inspire your creativity and help ensure the best outpost patrol flag is created for camp!

- **Essentials:** Include essential elements like the camp name, date, verse, location, church name, outpost number, and patrol name.
- Unique Design: Create a flag with a distinctive design shape.
- Flag Standard: Incorporate a flag standard using poles, usually lashed together.
- **Colorful Appearance:** Avoid "snow" on the flag by using vibrant colors with minimal to no white space.
- 3D Elements: Add a creative 3D element to make the flag truly stand out.
- **Collaborative Effort:** Ensure it's clear that the boys participated in making the flag, as those crafted by the boys receive higher scores!

Outpost Patrol Song Creation Guidelines

These important guidelines are here to inspire your creativity and help ensure the best outpost song is written for camp!

- **Engaging and Original Melody:** Create a song that is unique, fun, and points others to Jesus. It can be inspired by a worship song, a wholesome cartoon tune, or an original melody. Please avoid using instrumental tracks from secular artists, even with new lyrics, so the song and message stays clear and Christ-centered.
- **Memorization:** Ensure that every patrol member has memorized the song.
- **Choreographed Movements:** Include synchronized movements in your performance. Songs led by the boys will earn higher scores.
- **Props and Instruments:** Using props or instruments is highly encouraged! Instruments made by the boys themselves will earn higher scores. Be sure to bring them with you, as Outposts will not be allowed to use the stage instruments or sound equipment during their song.
- **Approval:** If there is any uncertainty about whether your song adheres to these guidelines, please have it reviewed and approved before camp.

Outpost Patrol Yell Creation Guidelines

These important guidelines are here to inspire your creativity and help ensure the best outpost yell is written for camp!

- **Strong Cadence:** Ensure the yell has a strong, rhythmic cadence—it's a chant, not a melody.
- **Memorization:** Every member of the patrol should have the yell memorized. Any patrol member should be able to lead the yell.
- **Synchronized Movements:** Incorporate synchronized movements into the performance. Yells led by the boys will earn higher scores.
- **Props and Instruments:** Using props or instruments is highly encouraged! Instruments made by the boys themselves will earn higher scores. Be sure to bring them with you, as Outposts will not be allowed to use the stage instruments or sound equipment during their yell.

Best Campsite **Y**

The criteria for the best campsite is based on safety, cleaniness, proper camp layout, a creativity.

Reminder:

Rule 5 – Leave No Trace

• "A Royal Ranger always leaves the campground better than he found it."

Keep campsites clean, restrooms and showers orderly, and do not cut trees or remove roadmarking logs. Leave no trace behind. No fires are permitted under any circumstances.

Best Campsite Criteria

- Layout Campsite should be clearly defined and separated from others using rope, rocks, etc.
- **Proper Camp Setup** Items should be organized and appropriately placed (kitchen, tents, tools, first-aid kit, fire extinguisher, etc.).
- **Cleanliness** No visible trash; campsite should be neat and well-maintained.
- Lashing Projects Highly encouraged! Projects will be inspected for correct lashing techniques. Lashing projects built by the boys will receive higher scores.
